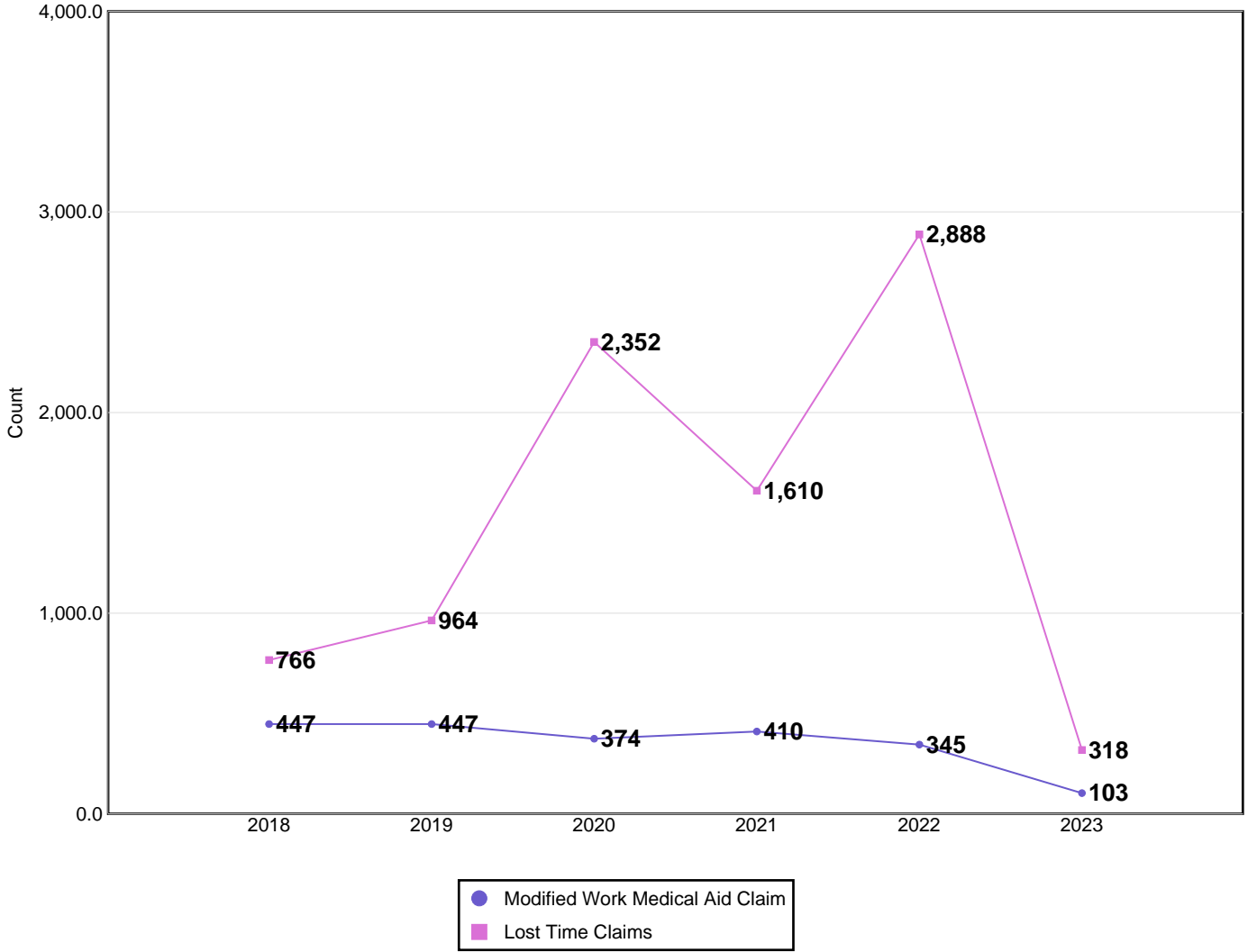

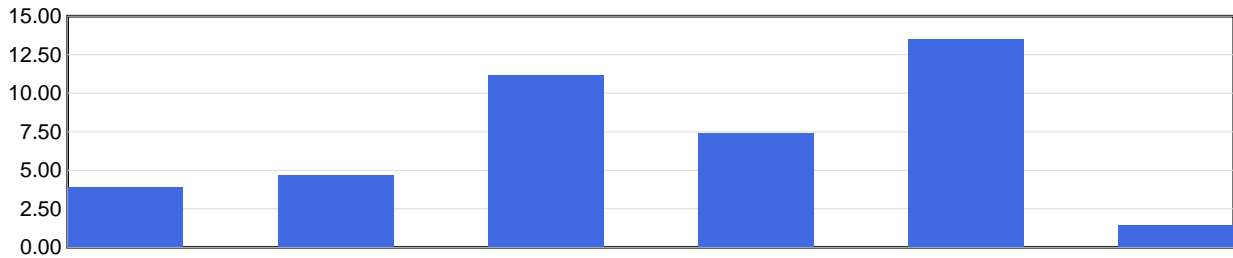

(Lost Time Claims per 100 Workers)



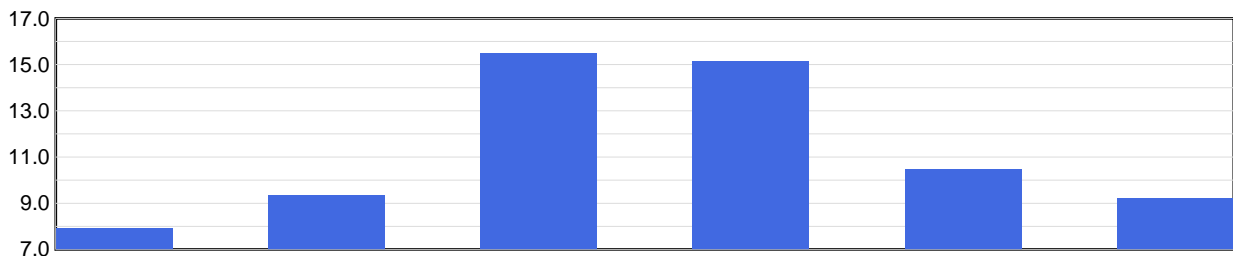

Severity Rates

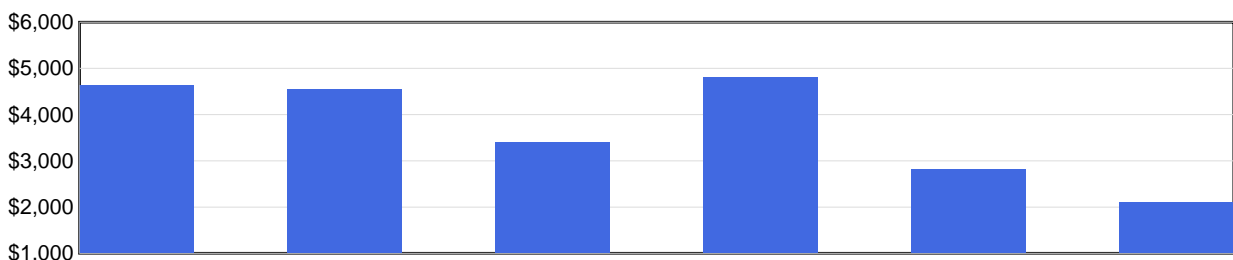
(Temporary Total Disability Days per Lost Time Claim)

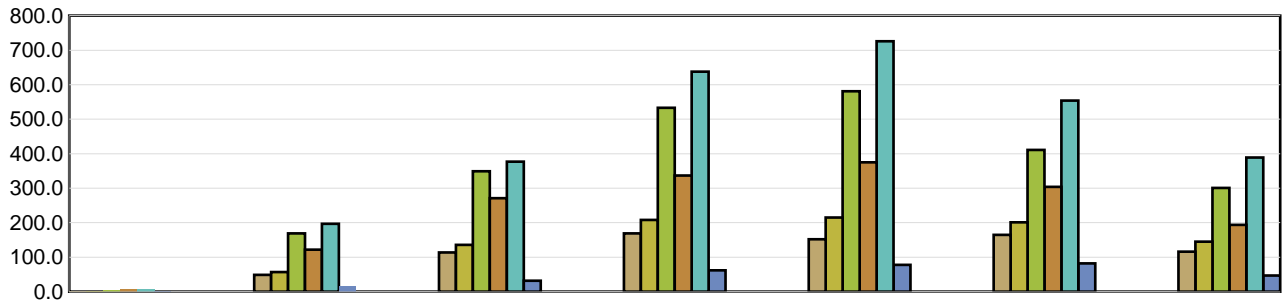

Number of LTCs

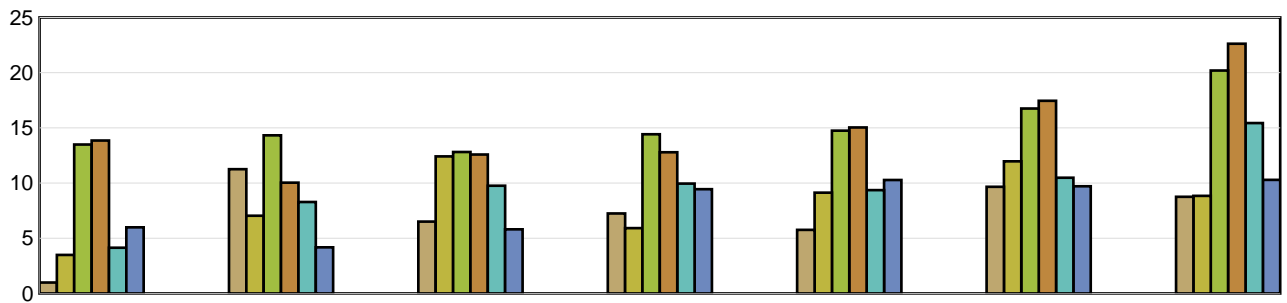
(by age of injured worker and by occurrence year)
