## Auditor Resources Have Been Updated

Did you know that the detailed First Aid kit content list is no longer included in the Alberta OHS Legislation? With the March 2023 update to First Aid requirements, the legislation now quotes CSA standards for the first aid kit contents. To view the content list to answer question 8.09 for the COR audit, you can choose one of these options:

- View the CCSA [Auditor Resources](#) on our website
  - Scroll down to the bottom to “8 2023 Changes to the OHS Code – Part 11 (First Aid)”.
  - Open the document and scroll towards the end of the bulletin for the detailed first aid content lists for the different types of first aid kits.

Once the employer, audit contact and auditor decide on the date to conduct their 2023 audit, the audit contact can visit our [website](#) to register the audit.

Once registered, your audit contact and lead auditor will receive the audit tool. If you need to hire an external auditor to conduct your audit you can view the updated [external auditor list](#) on our website.

Remember, CCSA’s suggested deadline for your audit submission is **November 30**. This allows time should there be any concerns with the audit during the quality assurance process.
