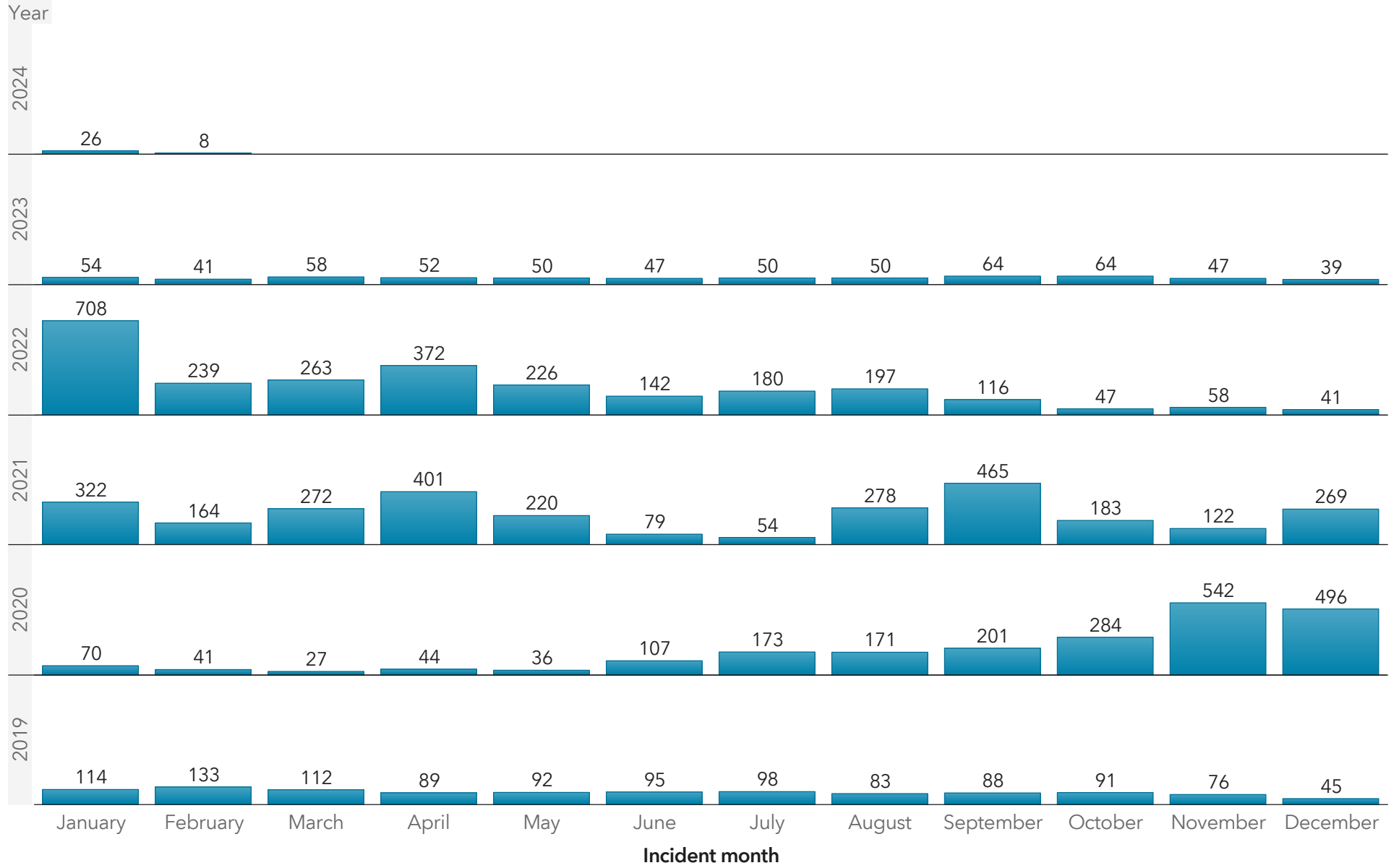

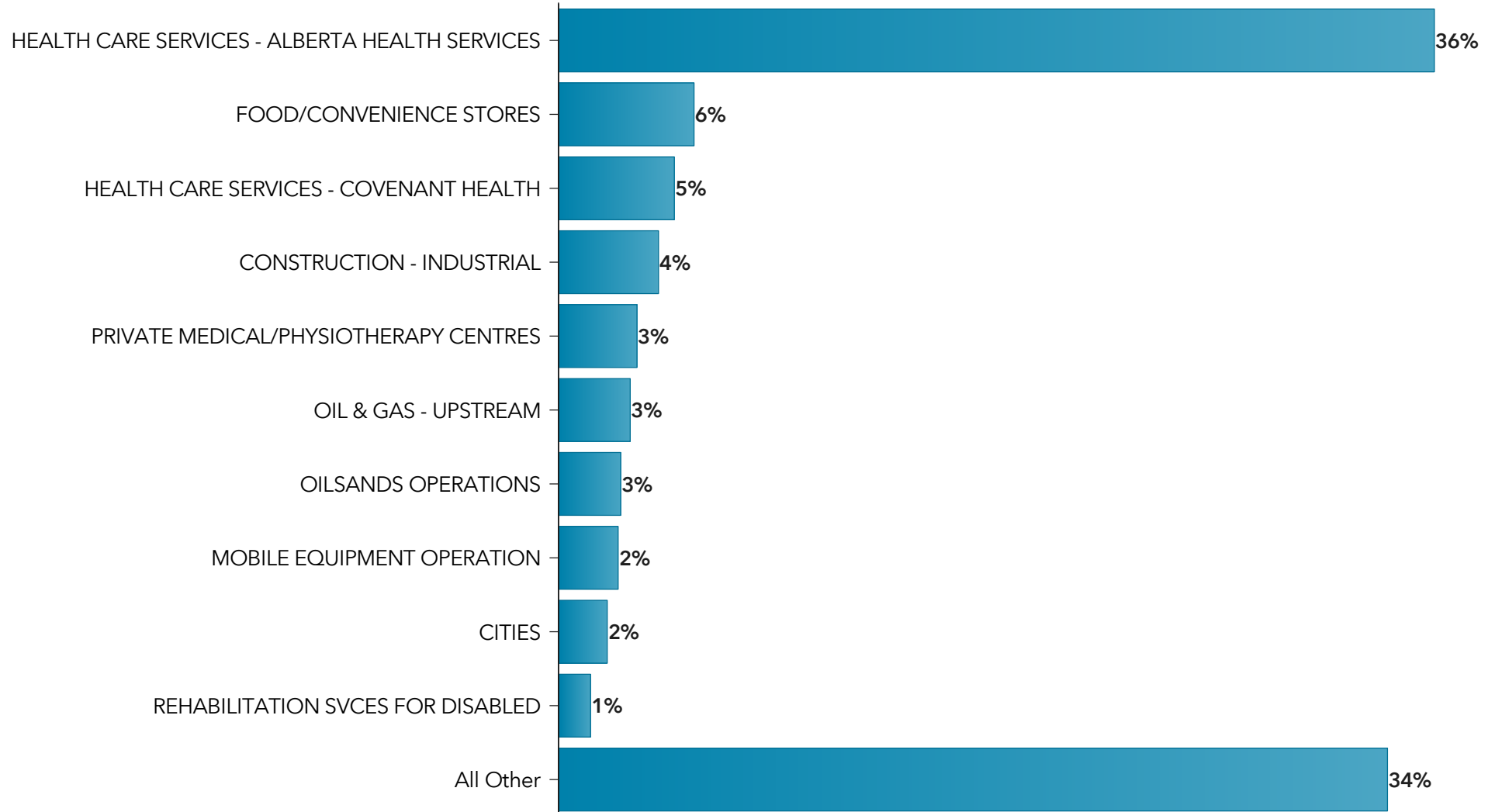
Number of PSIs, by incident month and year, 2019-2024

Top 10: Industries involved in PSIs, 2019-2024



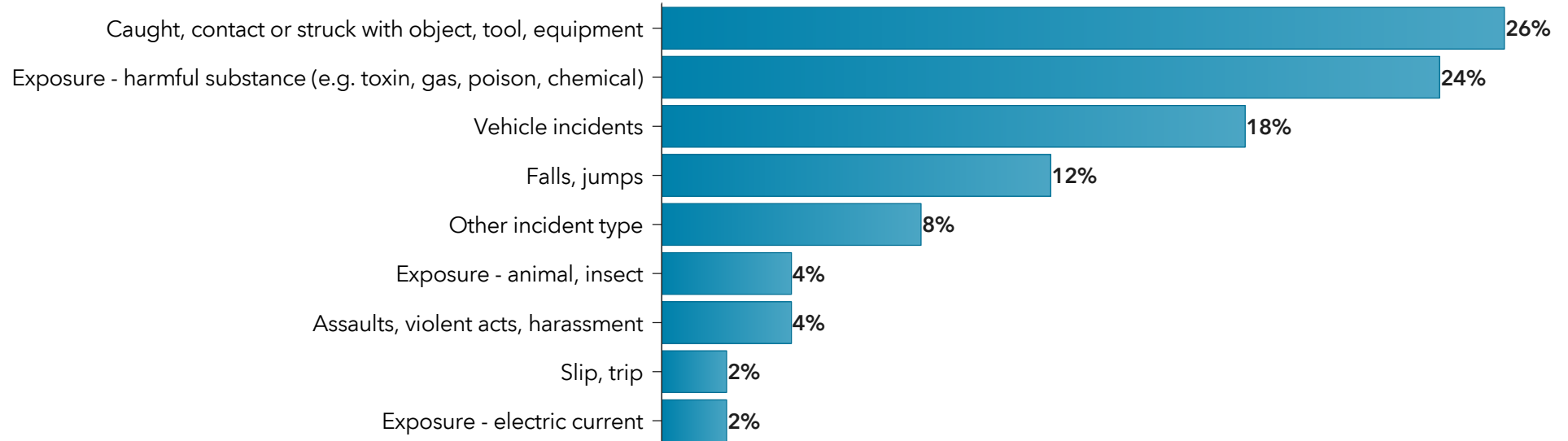

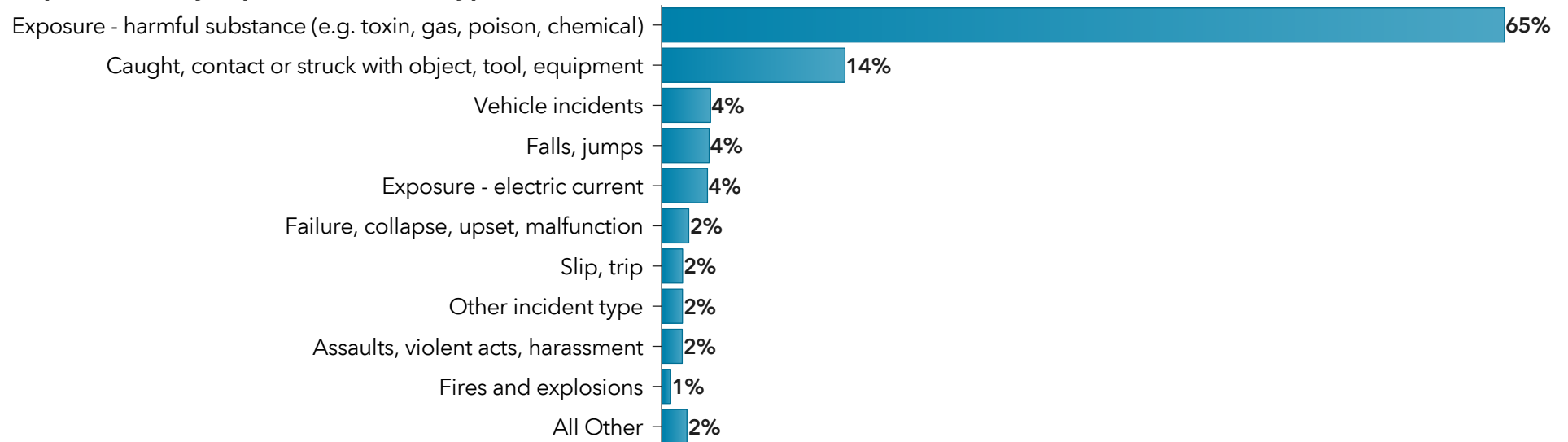

Top 10: PSIs by reported incident type, 2024



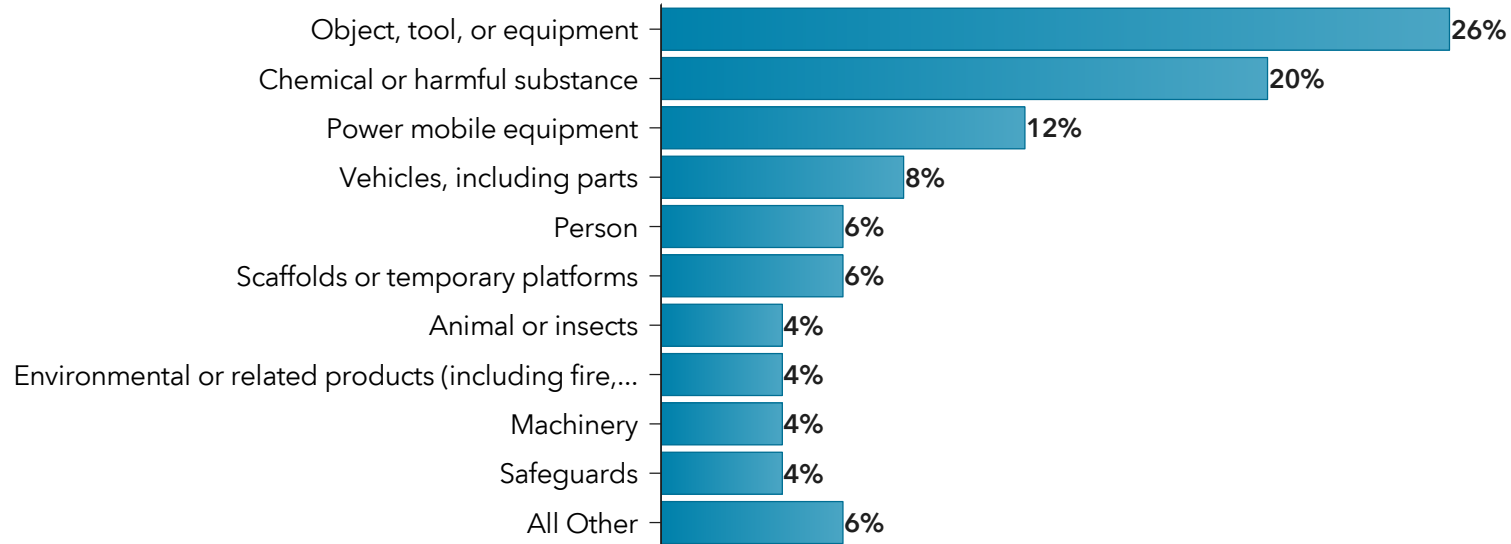

Top 10: PSIs by reported incident type, 2019-2023



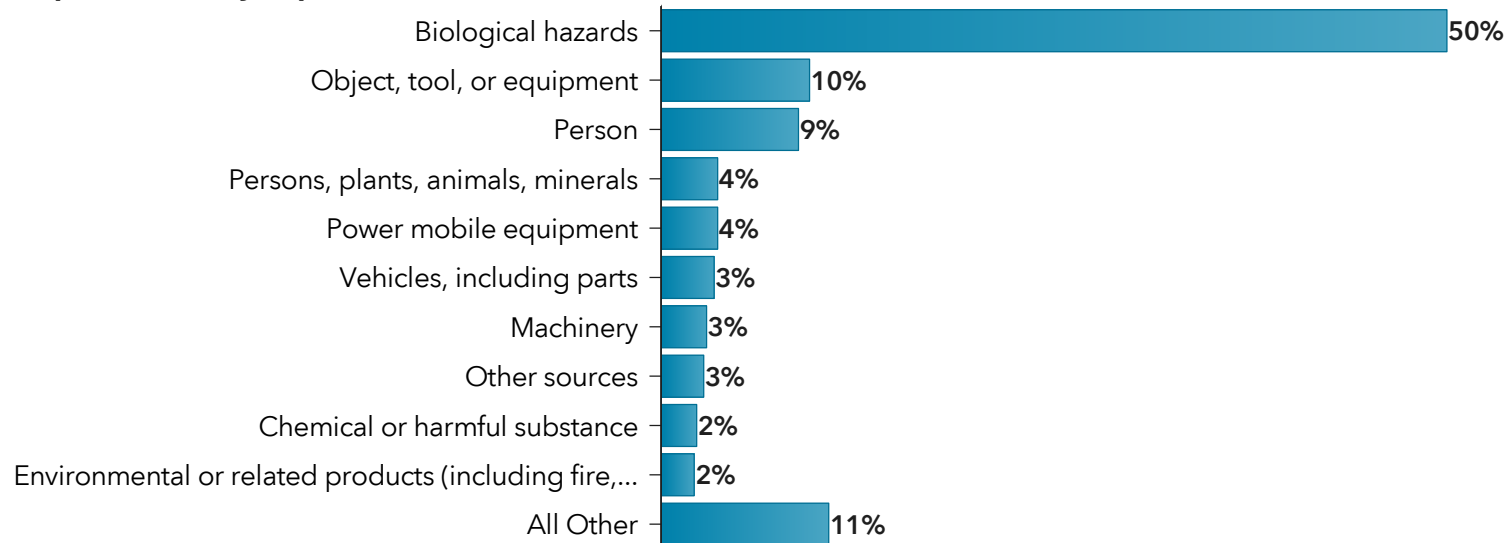

Top 10: PSIs by reported source of incident, 2024



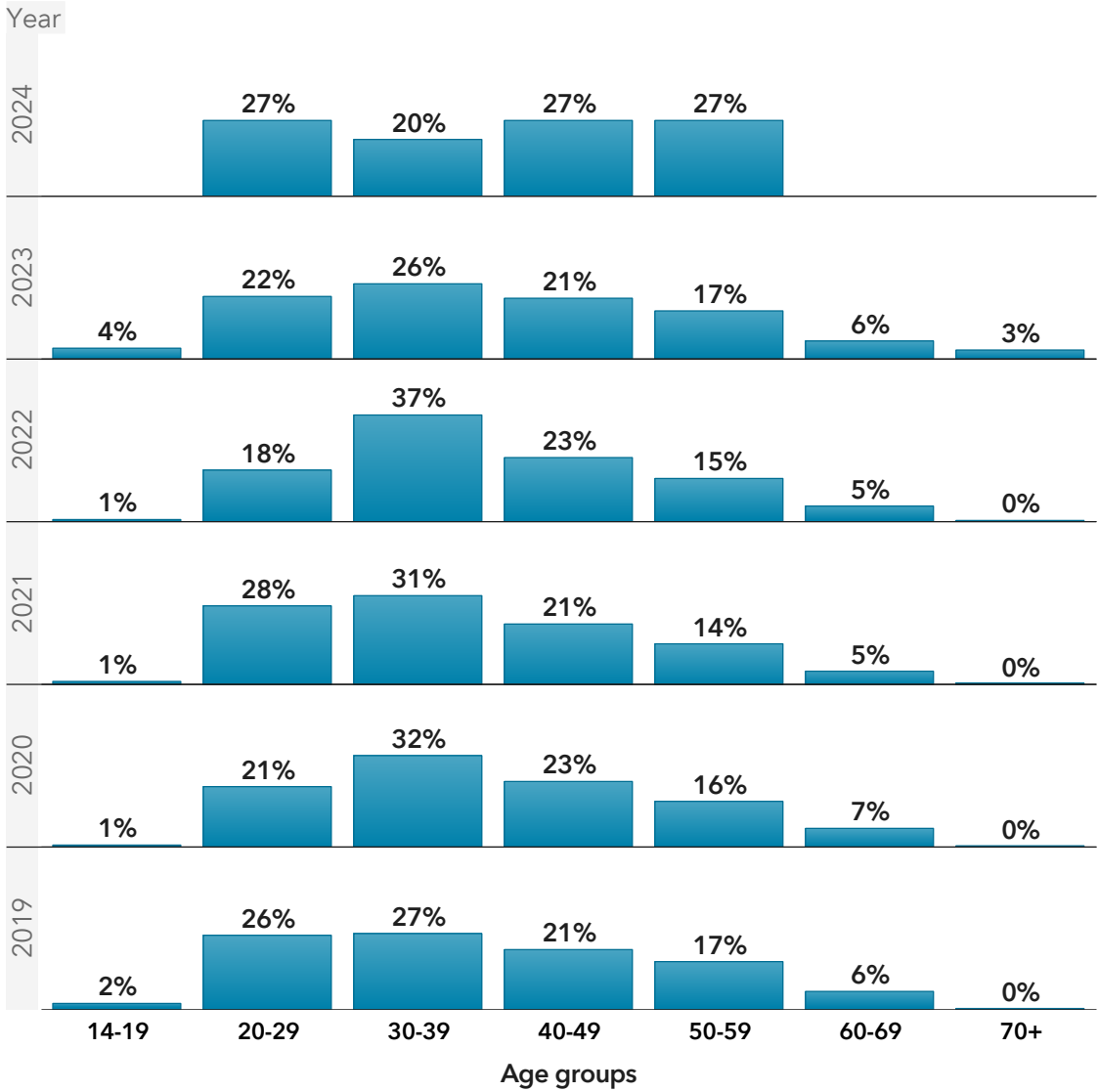

Age distribution of PSI injured persons, 2019-2024

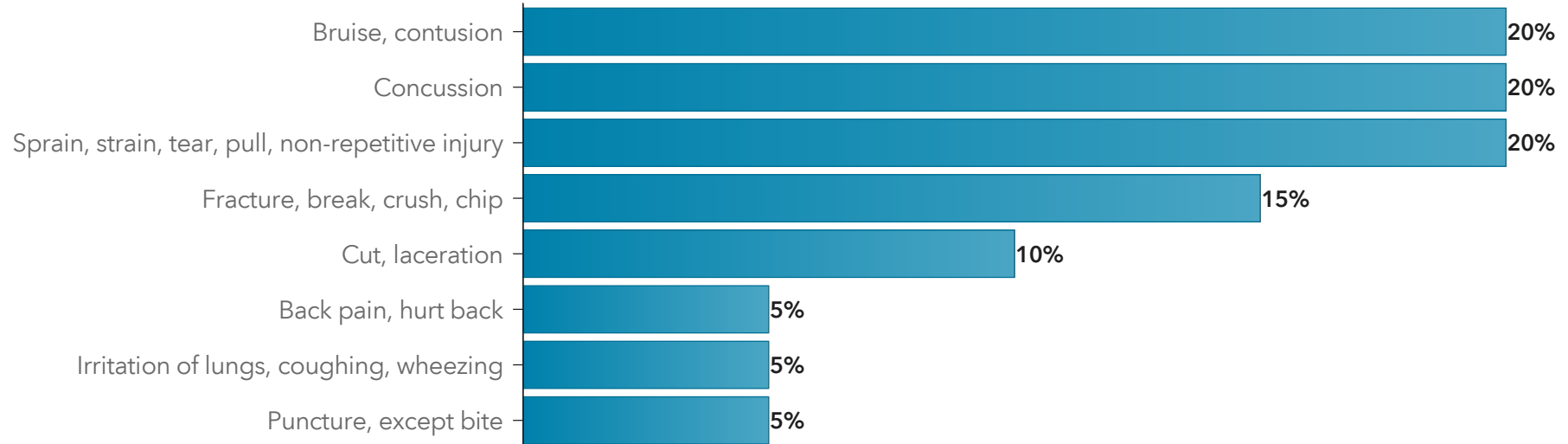

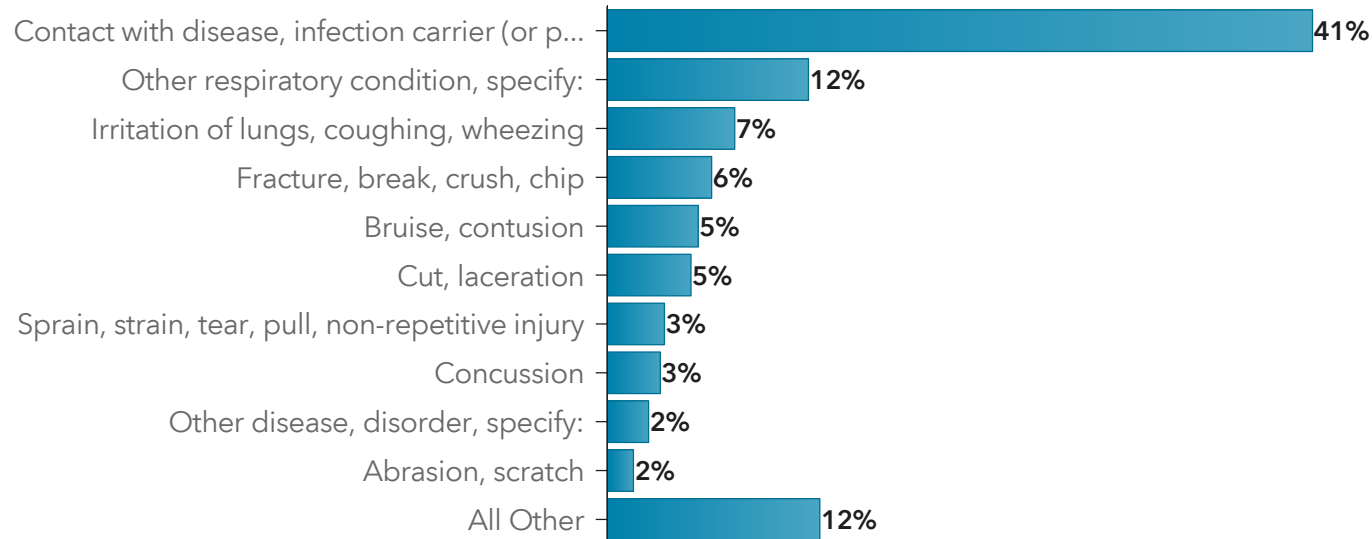

Top 10: PSIs by type of injury reported, 2019-2023

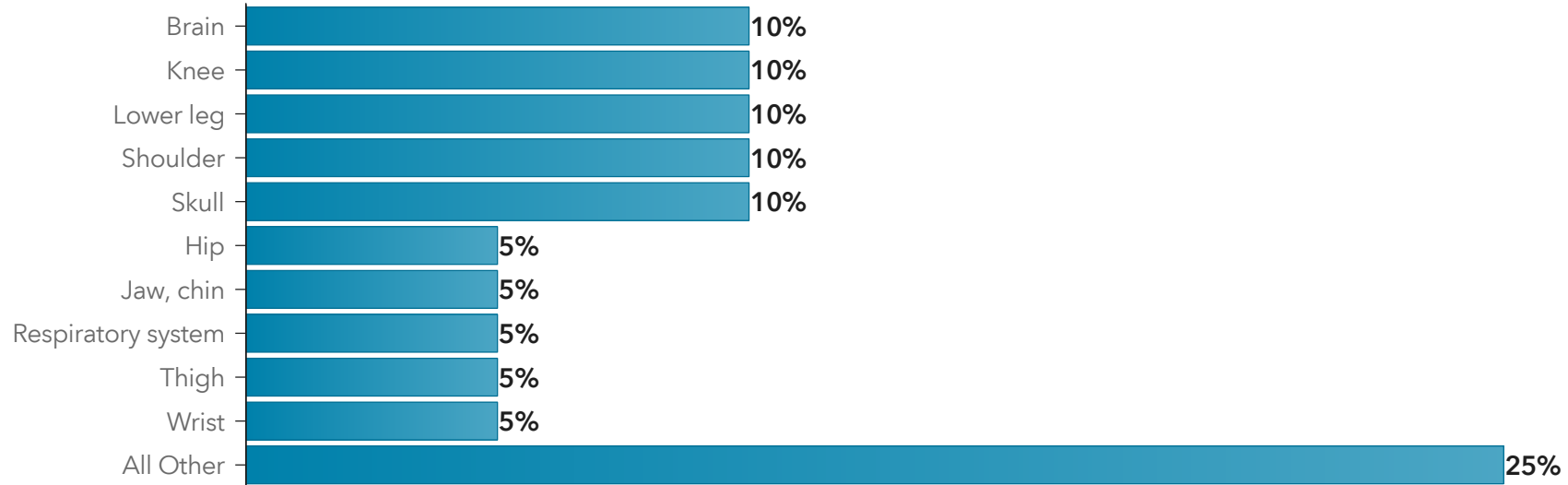

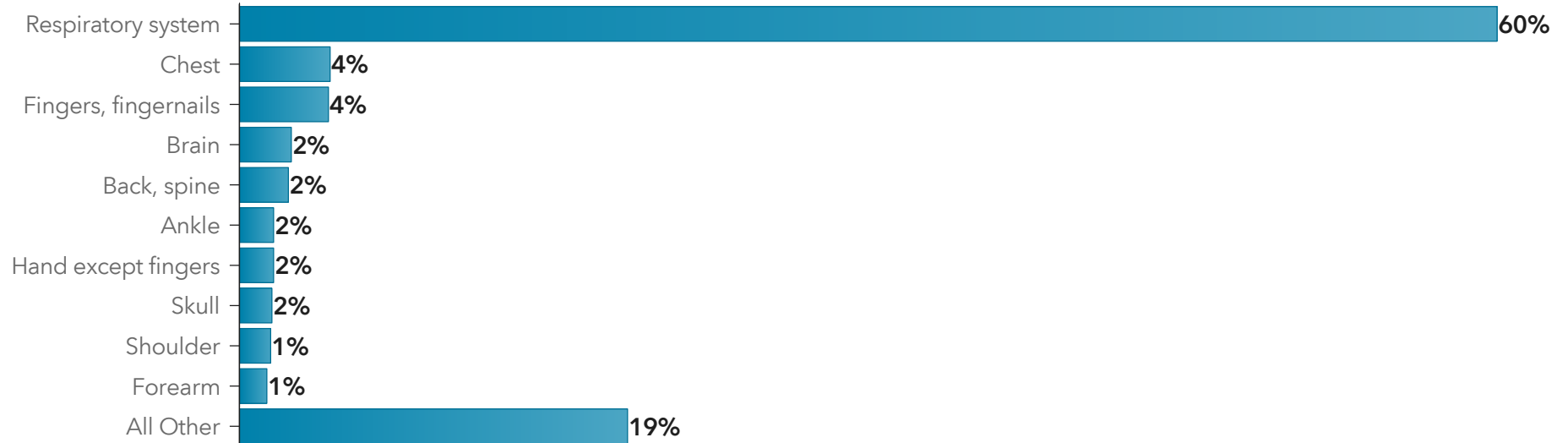
