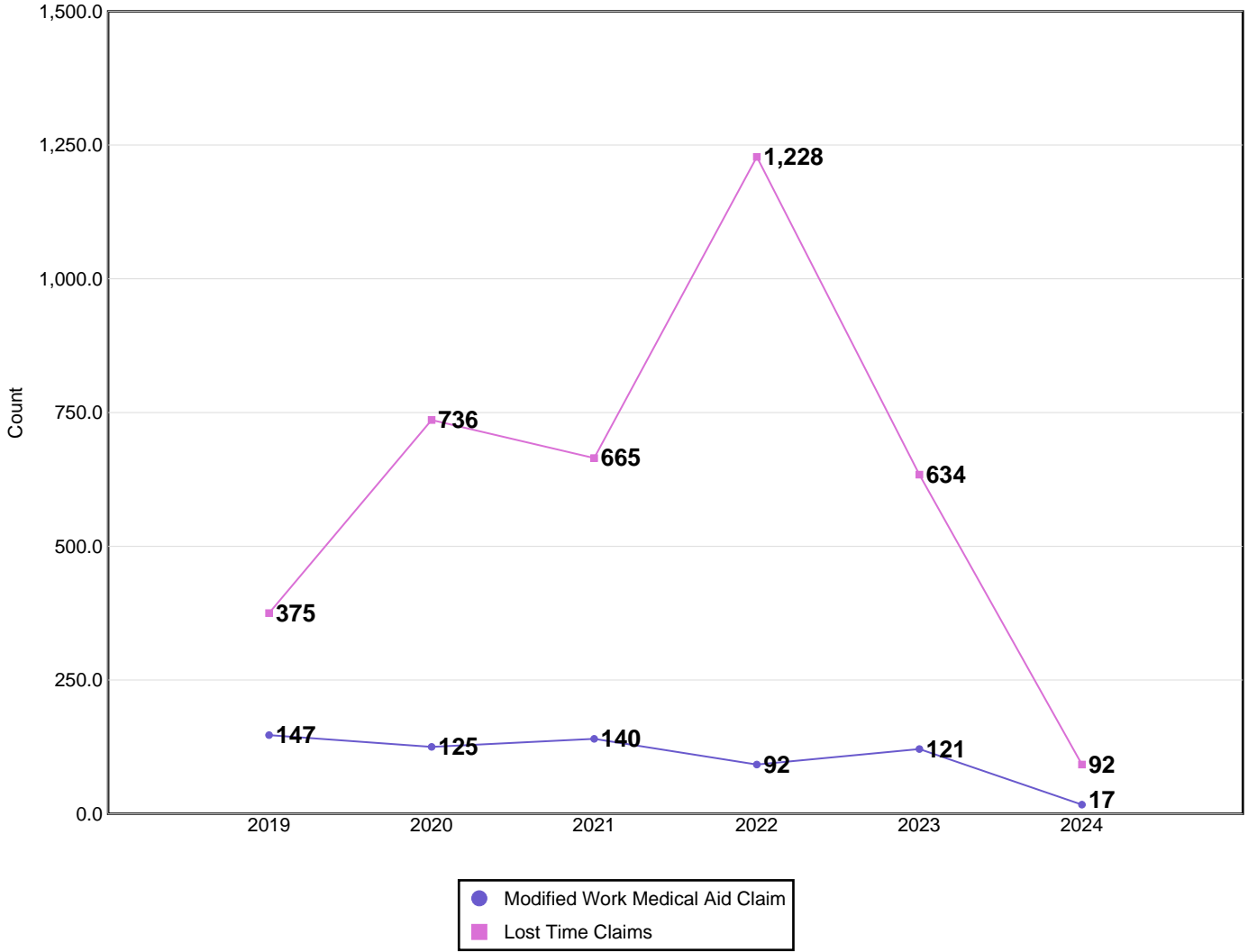

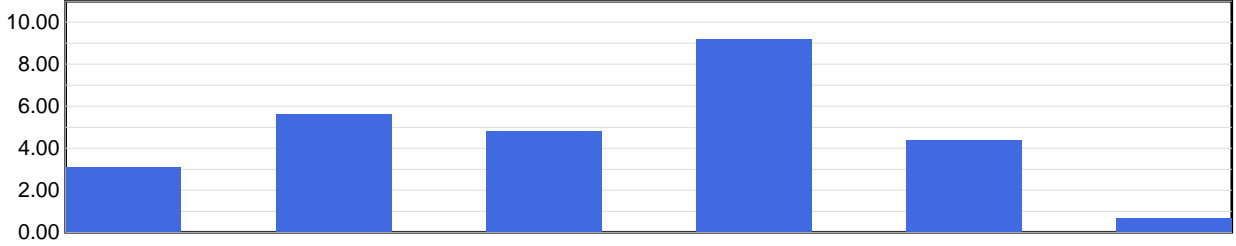

(Lost Time Claims per 100 Workers)



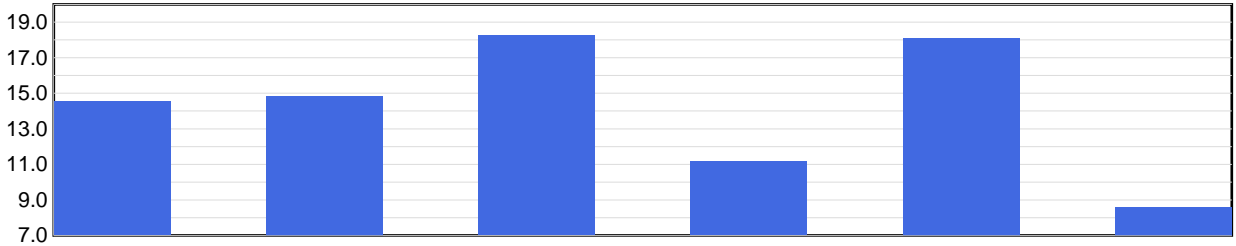

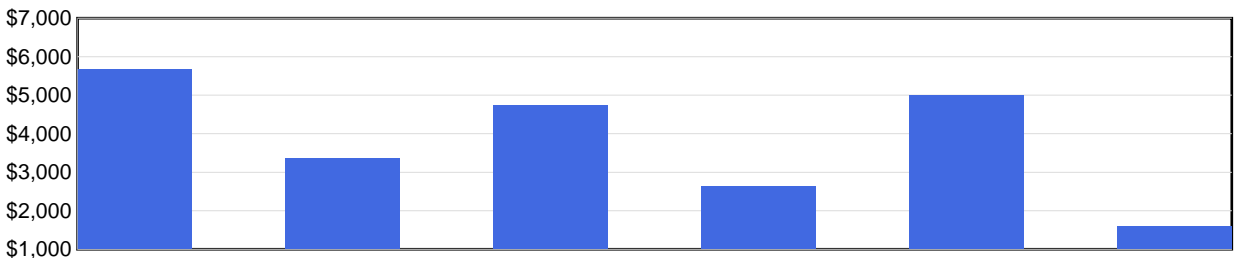
(Temporary Total Disability Days per Lost Time Claim)

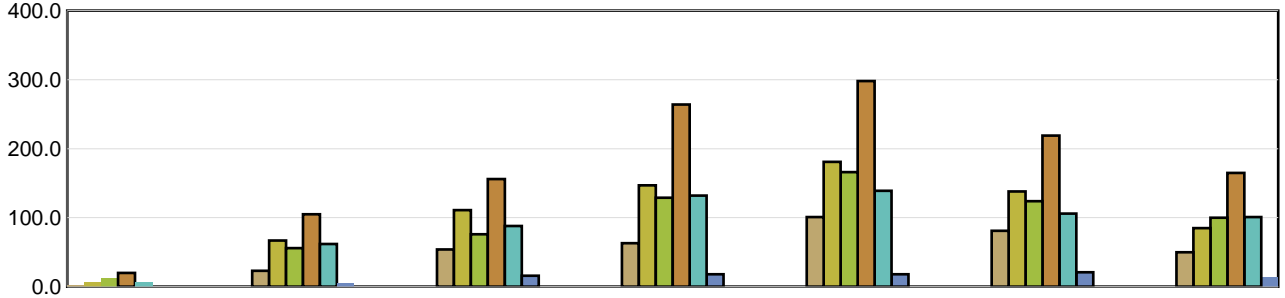

(by age of injured worker and by occurrence year)

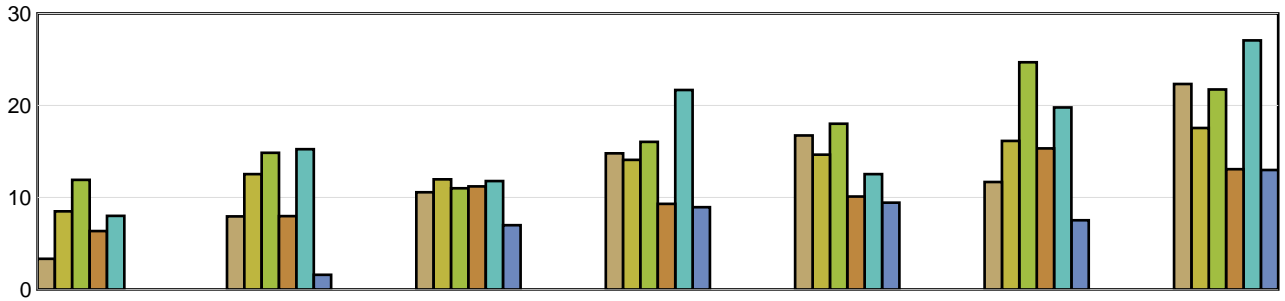
