Interview Cohort Breakdown



Now that we have had a few audits completed through AuditSoft and have had the opportunity to evaluate the data submitted, we are ready to trial removing the requirement to provide the breakdown of the positive response rate by each interview cohort group in the audit justification notes. This means for the remainder of the year, on a trial basis, the CCSA will no longer

require an interview cohort breakdown for interview questions only, as the AuditSoft tool accurately enters the % of positive indicators for each question appropriately.

Auditors are encouraged to assess whether the cohort breakdown adds value to the employer to support specific suggestions for improvement and, if so, include the cohort breakdown when warranted.

Quantification is still required for questions that are validated by documentation and observation.

The AuditSoft Scorecard feature will soon be enabled as we continue to receive more audits.

The AuditSoft Scorecard is intended to provide companies with a comprehensive summary of their Health & Safety program and provide guidance on future OHS initiatives through continuous improvement suggestions. Stay tuned for more information!

Audit Tip of the Month - Questions 10.07 and 10.08

10.07. Was a plan developed to address identified OHSMS deficiencies from the previous evaluation/audit?

- **10.07.** is only looking to see if an action plan was developed from the deficiencies identified in last year's audit.
- Note: Post-Audit Action Plan must include 3 criteria. These are 1) measurable action items, 2) proposed completion dates, and 3) individuals responsible for follow-up.


10.08. Has the plan been implemented?

- **10.08.** is looking to see if the identified deficiencies in the action plan have been initiated or implemented.
- Note: the measurable action items (identified deficiencies) do not need to have been implemented/completed; if the measurable action items were initiated, an auditor can award points.
